

AGREEMENT WITH BIG ROCK CHARTERS LLC TODAYS DATE____

A minimum deposit of \$500 and this signed contract is required to hold the date and time for your event. The boat is no longer available for charter during this time. Because charters rarely book on short notice, reservations that are cancelled prior to 30 days before the event will receive a 50% refund on the deposit. Any reservations that cancels within 30 days of the event are non-refundable. After 90 days, the Square transaction fee is no longer refundable per Square policy.

COVID-19: Due to possible operating restrictions or guests inability to travel, charters will be able to reschedule prior to 14 days before the event with no additional fees. _____

Final count, menu selections, and balances must be paid within 10 days of the scheduled event. You may not lower your guest count at this point, as food, linens, and staff are ordered. However, we will attempt to accommodate last-minute guests whose passage may be billed to a credit card. _____

Multiple charters may be booked in a single day. To give staff adequate break down and set up for the next event, your guests will be allowed to board 10 minutes prior to your charter time and are expected to be disembarked within 15 minutes after docking. If any guests remain on board after the allotted time, the customer will be billed for additional vessel time. If all guests are not present at time of charter, you may request to remain at the dock until guests arrive; however, your boat time starts at your originally scheduled departure.

Customer agrees to be responsible for any and all liability and damage done to the premise during the setup, the actual event and break down by customer, customer's guests and customer's suppliers as well as other third parties who are present at the customer's request. _____

In addition, the customer will be responsible for all fines, loss of business, assessments and liability as a result of such action. _____
